## 2011 FSA County Committee Elections

The elections of agriculture producers to Farm Service Agency (FSA) county committees is important to ALL farmers and ranchers, whether beginning or long-established, large or small. It is crucial that every eligible producer participate in these elections because FSA county committees are a link between the agricultural community and the U.S. Department of Agriculture.

County Committee (COC) members are a critical component of FSA operations. The intent is to have the COC reflect the makeup of the producers and to represent all constituents. This means wherever possible, minorities, women or lower income producers need to be on the committee to speak for these underrepresented groups.

County committees provide local input on commodity price support loans and payments, conservation programs, incentive, indemnity and disaster payments for some commodities, emergency programs and payment eligibility.

FSA county committee members apply their judgment and knowledge to make local decision and operate within official regulations designed to carry out federal rules, regulations and laws.

### Election Period

June 15, 2011 – COC nomination period begins.

Aug. 1, 2011 - COC nomination forms (FSA-669A) due at the local USDA Service Center

Nov. 4, 2011 – COC ballots mailed to eligible voters

Dec. 5, 2011 - Last day to return completed COC ballots to the USDA Service Center

## Who Can Hold Office

To hold office as a county committee member, a person must meet the basic eligibility criteria as follows:

- Participate or cooperate in a program administered by FSA
- Be eligible to vote in a county committee election
- Reside in the LAA in which the person is a candidate

Candidates must not have been:

- Removed or disqualified from the office of county committee member, alternate or employee
- Removed for cause from any public office or have been convicted of fraud, larceny, embezzlement or any other felony
- Dishonorably discharged from any branch of the armed services.

Nominees must complete and sign form FSA-669A available at USDA Service Centers and online at:

Nomination forms for the 2011 election must be postmarked or received in the local USDA Service Center by close of business on Aug. 1, 2011.

Agricultural Producers who are residents in the LAA holding the election and who participate or cooperate in an FSA program *and are of legal voting age* may be nominated *to serve on the county committee*.

## LAA's Accepting Nominations

Each year, an election is held in an LAA to replace the committee member whose three-year term is expiring. In counties with three LAAs, one seat is up for election. Currently

## NOTICE TO HISPANIC AND/OR WOMEN FARMERS OR RANCHERS

### COMPENSATION FOR CLAIMS OF DISCRIMINATION

If you believe that the United States Department of Agriculture (USDA) improperly denied farm loan benefits to you between 1981 and 2000 because you are Hispanic, or because you are female, you may be eligible to apply for compensation.

LAA 2 is up for election. LAA – 2 serves the central portion of Payette County lying north of the Farmers irrigation canal, extending as far east as the Gem County line while surrounding the outer lying areas of New Plymouth and the south east sections of Fruitland while extending as far north as Willow Creek drainage, with the western section bordering the Oregon State line. New beginning farmers and ranchers are encouraged to participate in the election process.

Nominations for candidates to run for the Farm Service Agency county committee election representing producers in a Local Administrative Area will be accepted from June 15 through Aug. 1, 2011.

Individuals may nominate themselves or others as candidates. Also, organizations representing socially disadvantaged minorities and women farmers or ranchers may also nominate candidates.

#### Who Can Vote

Agricultural producers of legal voting age (18 years) may be eligible to vote if they participate or cooperate in any FSA program. A person who is not of legal voting age but supervises and conducts the farming operations of an entire farm may also be eligible to vote. More information about voting eligibility

#### Farm Reconstitutions

At FSA, farms are “constituted” to group all tracts having the same owner and the same operator under one farm serial number. When changes in ownership or operation take place, a farm reconstitution is necessary. If multiple owners and/or operators do not agree about program participation and want to separate acres by programs, for example to enter only a segment of property into the new ACRE program, then producers should inquire about a reconstitution of the farm at the local FSA office.

The reconstitution—or recon—is the process of combining or dividing farms or tracts of land based on the farming operation. NOTE: to be effective for the current year, recons must be requested by August 1, 2011 for farms enrolled in specific programs

#### Crop Reports

The timely and accurate reporting of acres for all crops and land uses, including failed acreage, can prevent loss of benefits for a variety of Farm Service Agency programs.

All cropland on the farm must be reported to receive benefits from the Direct and Counter-cyclical Program, marketing assistance loans and Loan Deficiency Payments. Conservation Reserve Program acreage must be reported to receive annual rental payments. And, crop acreage for Non-insured Crop Disaster Assistance Program (NAP) must also be reported.

Crop reports, form FSA-578, Report of Acreage, must account for all cropland on a farm, whether idle or planted. Producers need to file their acreage reports by June 30, 2011.

**Prevented Planting:** Prevented planting needs be reported no later than 15 calendar days after the final planting date.

**Failed Acreage:** Reports of failed acreage must be filed before disposition of the crop, and producers must be able to establish to the satisfaction of the county committee that the crop failed and was prevented from being replanted through the normal planting period because of natural disaster conditions.
