County Committee Elections

“FSA Counts on You”

Since COC elections happen only once a year, here is an election refresher. For election purposes, counties are divided into *local administrative areas*, or LAAs. Each LAA selects one producer to serve a three-year term on the Farm Service Agency county committee.

Each year, an election is held in an LAA to replace the committee member whose three-year term is expiring. In counties with three LAAs, one seat is up for election.

Nominations

Candidate nominations for the FSA county committee election will be accepted June 15 through Aug. 3, 2009.

Producers who are residents in LAA #3 (Lyman school district boundary) holding the election and who participate or cooperate in an FSA program and are of legal voting age may be nominated to serve on the county committee.

Individuals may nominate themselves or others as candidates. Also, organizations representing socially disadvantaged minorities and women farmers or ranchers may also nominate candidates.

The nomination form, FSA-669A, is available at the county office or may be downloaded from <http://www.fsa.usda.gov/FSA/webapp?area=newsroom&subject=landing&topic=cce>.

To be valid, the nomination form must be signed by the person being nominated, indicating agreement to serve if elected. The completed nomination form must be

returned to the county office by the close of business on Aug. 3, or postmarked by midnight Aug. 3, 2009.

Voting

Ballots will be mailed to eligible voters beginning Nov. 6, and must be returned to the county office by the close of business on Dec. 7, or postmarked by midnight Dec. 7, 2009.

Agricultural producers of legal voting age can vote if they participate or cooperate in any FSA program. A person who is not of legal voting age but supervises and conducts the farming operations on an entire farm can also vote.

No one can be denied the right to vote because of race, color, national origin, sex, religion, age, disability, political beliefs, sexual orientation or marital or family status.

Candidate Eligibility

To hold office as a county committee member, a person must meet the basic eligibility criteria:

- Participate or cooperate in a program administered by FSA
- Be eligible to vote in a county committee election
- Reside in the LAA in which the person is a candidate
- Not have been:
 - Removed or disqualified from the office of county committee member, alternate or employee
 - Removed for cause from any public office or have been convicted of fraud, larceny, embezzlement or any felony
 - Dishonorably discharged from any branch of the armed services.

For additional clarification about county committee elections, contact your local county office staff.

DCP & ACRE Signup Deadline

Signup for the 2009 Direct and Counter-cyclical Payment (DCP) Program has been extended until August 14, 2009. FSA will not accept any late-filed applications. Signup in the ACRE option is also available through August 14, 2009.

Crop Reporting

The annual requirement of reporting to the FSA office can be referred to as crop reporting, acreage reporting, or crop certification. Filing an accurate and timely report for all crops and land uses, including failed acreage, can prevent loss of benefits for a variety of Farm Service Agency programs. All cropland on the farm must be reported to receive benefits from the Direct and Counter-cyclical Program, marketing assistance loans and Load Deficiency Payments.

The certification form FSA-578, Report of Acreage, must account for all cropland on a farm, whether idle or planted. The producer certification deadline for Crop year 2009 is Wednesday, July 01, 2009.

CRP & NAP Certification

Conservation Reserve Program acreage must be reported to receive annual rental payments. And, crop acreage for Non-insured Crop Disaster Assistance Program (NAP) must also be reported.

Failed Acreage:

Reports of failed acreage must be filed before disposition of the crop, and producers must be able to establish to the satisfaction of the county committee that the crop failed and was prevented from being replanted through the normal planting period because of natural disaster conditions.

Controlled Substances

Program participants convicted under federal or state law of any planting, cultivating, growing, producing, harvesting or storing a controlled substance are ineligible for program payments and benefits.

If convicted of one of these offenses, the program participant shall be ineligible during that crop year and the four succeeding crop years for direct and counter-cyclical payments, price support loans, loan deficiency payments, market loan gains, storage payments, farm facility loans, Non-insured Crop Disaster Assistance Program payments or disaster payments.

Program participants convicted of any federal or state offense consisting of the distribution (trafficking) of a controlled substance shall, at the discretion of the

court, be ineligible for any or all program payments and benefits:

- for up to 5 years after the first conviction
 - for up to 10 years after the second conviction
 - permanently for a third or subsequent conviction.
- Program participants convicted of federal or state offense for the possession of a controlled substance shall be ineligible, at the discretion of the court, for any or all program benefits, as follows:
- up to 1 year upon the first conviction
 - up to 5 years after second or subsequent conviction.

Farm Reconstitutions

For FSA program purposes, tracts having the same owner and the same operator are grouped under one farm serial number. When changes in ownership or operation take place, a farm reconstitution is necessary.

The reconstitution—or recon—is the process of combining or dividing farms or tracts of land based on the farming operation. Remember, to be effective for the current year, recons must be requested by **August 1** for farms enrolled in specific programs.

Contact your FSA office to discuss the various methods of Reconstitution including: the Estate Method, the Designation of Landowner Method, the DCP Cropland Method and the Default Method.

Banking Changes?

Almost all Farm Service Agency payments are made electronically using Direct Deposit. This innovation has cut down on the number of missing and late payments and reduced the time required to move funds. It has been calculated that having a problem with a payment is 20 times greater with checks than with Direct Deposit. Another benefit is that Direct Deposit to your account can be made within 48 hours.

To keep the system running smoothly, it's critical to keep the county office staff up to date on changes you might make in your financial institutions.

If you have changed accounts or institutions that might affect the direct deposit of your FSA payments, contact the FSA county office so we can update our files to insure continued uninterrupted service.

Ownership or Lease Changes

Keeping our records up to date is extremely important to the administration of FSA programs. Please notify us promptly when changes occur. Our records are only as current as we are made aware of the changes. We appreciate everyone who has reported changes timely! Thank you!

Online Services

Producers, if you have Internet access you can electronically log on, fill out and print a variety of FSA paper forms in the comfort of your home as your schedule allows. You can also register for secure electronic access that will allow you to electronically sign and transmit some forms directly to the county office staff. If you are new to the website, first you will want to obtain a Level 2 USDA Service Center Customer ID and password at: <http://www.eauth.egov.usda.gov/> and then click on "Create an Account Page" link.

USDA eAuthentication is the system used by USDA agencies to enable customers to obtain accounts that will allow them to access USDA Web applications and services via the Internet. This includes things such as submitting forms electronically, filing eLDPs, completing DCP contracts, filling out surveys online, and checking the status of your USDA accounts.

If you already have a Customer ID and password, then click on the following eForms website at: <http://forms.sc.egov.usda.gov/eforms/mainservlet> and then click on the "Sign In" button. A disclaimer window will open and after you read the "Warning message", click on the "Continue" button.

Then the USDA Web services page will open to the eAuthentication login page. Enter your login User ID and password and then click on the "Login" button. To sign and transmit forms electronically, you must sign-up and get a User ID and password.

Submitting an e-Form is convenient. You can access information anytime day or night seven days a week. It's faster and forms along with applications can be submitted and received in the county office in a matter of minutes, not days or weeks.

Changes in Payment Limitations

The applicability of payment limitation provisions have expanded over the last 39 years to include more programs. See below for key changes.

New forms for 2009 and subsequent years

Anyone that plans to participate in 2009 programs is required to submit a completed CCC-902, CCC-926, and CCC-901, if applicable, for payment

eligibility and payment limitation purposes. The form used prior to 2009 was named CCC-502.

Another change for 2009, all must make a contribution in an entity

All partners, stockholders, or members with an ownership interest in the legal entity must make an active contribution, whether compensated or **not** compensated. That active contribution must include:

- personal labor, or
- active personal management,
- or a combination of active personal labor and active personal management to the farming operation;

Note: that there are exceptions for spouses.

Power of Attorney

For those who find it difficult to visit the county office personally because of work schedules, distance, health, etc., FSA has a power of attorney form available that enables you to designate another person to conduct your business at the office.

If you are interested, please contact our office or any Farm Service Agency office near you for more information. If you want a crop loan, a power of attorney form will need to be completed for husband and wife, if both do not come into the office to sign the forms on the day the loan is disbursed.

Wool Loan Deficiency Payments (LDP)

Wool producers are reminded that they may either choose to file a "certified" wool LDP based on an Estimate of the pounds of wool sheared in 2009, OR Producers may bring their 2009 wool sales receipt to the county office and file for a Wool LDP based on the date that "beneficial interest" was lost (i.e. sales date).

As of the date of the preparation of this newsletter the Wool LDP Rate remains the highest it has been thus far in 2009.

Payment Eligibility documents are a requirement of the program. A complete and signed 2009 Crop Acreage Report is also required to receive LDP benefits.

Filing deadline for the 2009 Wool LDP is January 31, 2010.

2009 Compliance

Compliance and spot checks will once again be utilized during the 2009 crop year. Instead of locally selecting farms, contracts, deficiency loans, etc. for spot check and review, a nationwide selection of producers is used to achieve an adequate statistical sampling of participating producers. Spot check selections are to be conducted based on a producer's participation in Conservation Reserve Program, Direct and Counter-cyclical Program, Loan Deficiency Program, etc.

County offices shall view and print their producer spot check lists as posted on the designated web site. If an entity is selected from the national database that is no longer farming or participating in the 2009 crop year, a notation shall be made on the spot check list. For more information about the new spot check selection procedure, feel free to contact your local office.

Special Accommodations

Reasonable accommodations will be made, upon request, for individuals with disabilities, vision impairment, or hearing impairment to attend or participate in meetings or events sponsored by the Farm Service Agency.
