Offerors are encouraged to propose labor rates from other Government contracts for which fair and reasonable determinations have already been made. The offeror shall identify the source contract and contact information for the contracting officer. These factors will remain static throughout the contract and will apply to both Labor Hour and Firm Fixed Price task orders.”

Is replaced with the following language:

- (1) “Part III: Fully burdened labor rates for each location, both on and off site are provided in Part II. Part III of Tab D shall include the breakdown of direct vs. indirect factors applied to labor and non-labor costs. Indirect rates will remain static throughout the contract and will apply to both Labor Hour and Firm Fixed Price task orders.

The breakdown will include:

- Escalation factor(s) applied to direct labor rates
- Combined indirect rate (includes overhead, G&A, profit, etc.) applied to Labor*
- Combined indirect rate applied to material (for negotiated task orders, awards and modifications) – see paragraph (4)
- Combined indirect rate applied to travel (travel is limited to direct costs only unless adequate justification is provided and accepted prior to award of contract) – see paragraph (4) for additional requirements.

*In lieu of providing a breakdown for labor rates, offerors may propose labor rates from other current Government contracts for which fair and reasonable determinations have already been made. The offeror shall identify the source contract, provide enough information to validate the labor rates in question and contract information for the contracting officer.
