Verifying TTPP Producer Financial Information

1 Overview

A Background

TTPP:

- helps tobacco quota holders and producers transition to the free market
- provides annual transitional payments for 10 years to eligible tobacco quota holders and producers
- payments began in 2005 and continue through 2014.

The annual payment cycle for TTPP is scheduled for processing in January 2010.

County Release No. 675 converted Financial Services web application existing data to implement 1 national view for any customer. Customers are now identified in Financial Services by TIN and TIN type **without** regard to physical location. The Financial Services web application was enhanced to support customers establishing assignments, joint payments, and direct deposits.

With County Release No. 675 affecting the Financial Services web application before other program payment cycles, County Offices should verify information **before** the January payment cycle to ensure that TTPP producer financial information is correct.

This notice provides guidance on verifying financial information for TTPP producers.

2 County Office Action

A Financial Services

County Offices should go into Financial Services to correct the following for all TTPP producers in the Service Center:

- assignments
- bankruptcy flag
- direct deposits
- joint payments
- other agency debt flag.

B FWADM Reports

The following 2 new FWADM reports have been developed to assist County Offices with verifying TTPP producer financial information:

- TTPP Bank Account Verification Report
- Financial Services Assignment by Program Report.

Note: If producers have **not** received prior TTPP payments, County Offices **must** manually verify SF-1199-A and CCC-956 with Financial Services web application to ensure accuracy.
