1 Clarification

A Background

8-LP, subparagraph 301.5 A states that producers may submit CCC-633 EZ, page 1 any time **after** January 1 for the applicable crop year.

CCC-633 EZ, page 1:

- allows producers to indicate their intentions to receive LDP benefits
- states terms and conditions for receiving LDP
- outlines methods for requesting payment
- is crop year specific and does **not** apply for subsequent crop years.

The Farm Security and Rural Investment Act of 2002 authorized LDP's through crop year 2007. Producers will **not** be allowed to sign CCC-633 EZ, page 1 for crop year 2008 unless authorized.

B Purpose

This notice provides policy and additional clarification on the earliest date CCC-633 EZ, page 1 for crop year 2007 may be submitted to a County Office or DMA.

2 Accepting CCC-633 EZ, Page 1 for Crop Year 2007

A Accepting CCC-633 EZ, Page 1

CCC-633 EZ, page 1:

- may be submitted by the producer for crop year 2007 during 2007 DCP signup that started October 1, 2006
- will be accepted for crop year 2007 any time during the loan availability period as long as the producer still has beneficial interest in the commodity
- shall match the farming entity on the 2007 CCC-509.

Example: The producer signs CCC-633 EZ, page 1 as an individual when updating the crop year 2007 CCC-509 on November 1, 2006. On March 1, 2007, the producer forms a corporation and the corporation does a succession on CCC-509. The corporation must complete a new CCC-633 EZ, page 1 to ensure that the LDP eligibility page 1 previously filed on November 1, 2006, is no longer valid.

3 Action

A State Office Action

State Offices shall ensure that the policies and procedures in this notice are uniformly followed by County Offices.

B County Office and DMA Action

County Offices and DMA's shall:

- begin accepting CCC-633 EZ, page 1 for crop year 2007 upon issuance of this notice
- inform producers that CCC-633 EZ, page 1 may be filed when updating crop year 2007 DCP signup at County Offices
- **not** accept CCC-633 EZ, page 1 for crop year 2008 unless authorized to do so.
